NSTC's EMDRIA-Approved Basic Training Programs

This program is longer and more extensive than EMDRIA requires (63 & 66 hours for in-person & virtual programs), to allow for better integration. It is unusual for its comprehensive focus on attachment-based developmental trauma, providing a scripted attachment & trauma history-taking and target/treatment planning process. It also incorporates the foundational theory of Structural Dissociation (TSDP) for work with Complex PTSD, with additional reference to Polyvagal Theory (PVT) and the principles of Anti-Racist Psychotherapy.

NSTC: All-Canadian content developed & delivered by Canadian Trainers...

Virtual programs are done on a 6:1 ratio, in four 2-day blocks. In-person programs are done on a 9:1 ratio, in two parts, of 4 & 3 days.
